PROPERTY ADDRESS

Details and address of the rated property.

AVPCC

The Australian Valuation Property Classification Code (AVPCC) is used to categorise your property for valuation purposes.

CAPITAL IMPROVED VALUE

The expected sale price of the property if it was sold at the time of valuation.

SITE VALUE

The value of your land without improvements, like a house.

NET ANNUAL VALUE

Five percent of the Capital Improved Value of your residential property.

RATE IN THE DOLLAR AMOUNT

Rate in the dollar amount or type of differential rate applied to valuation (if used)*

MUNICIPAL CHARGE

This is a fixed amount paid equally by every property and is an option used by some councils. Councils may raise up to 20 per cent of their rates and charges revenue via this fixed amount.

These are charges collected by the council to manage waste, including recycling, green waste and general waste.
